
## Terms & Conditions

#### 1. This rate card is in effect from 1st April 2018.

- 2. All rates are subject to change at the sole discretion of DB Corp. Ltd. (Radio Division). However, Advertisers/Advertising agencies will be notified at least one week in advance of the proposed rate change. The revised rate card will be sent by ordinary post to the Advertiser/Advertising agencies at their address last available with DB Corp. Ltd. (Radio Division).
- 3. GST as applicable from time to time, shall be calculated on the net amount, (i.e. after deducting agency Discount) and would be borne only by the Advertiser/Advertising agencies. All payments to be made to Advertiser/Advertising agencies shall be subject to the deduction of tax at source, wherever applicable, as per the provisions of the Income Tax Act, 1961.
- 4. Invoices are the final proof of broadcasting and no further proof of broadcast will be provided. Monitoring reports from any independent agency that contradict the broadcast will not be entertained.
- 5. No deduction(s) will be made by the Advertiser/Advertising agencies or are permitted whilst settling /paying the invoice raised by DB Corp. Ltd. (Radio Division). Any disputes regarding the amounts mentioned in the invoice should be brought into notice of DB Corp. Ltd. (Radio Division) by the Advertiser/Advertising agencies within 14 days from the date of invoice. The Advertiser/Advertising agency does not reserve any right to make any deduction from the invoice. DB Corp. Ltd. (Radio Division) will issue credit notes for accepted reductions (if any) in the invoices.
- 6. In accordance with DB Corp. Ltd's (Radio Division) policy, booking once committed cannot be cancelled. The advance received shall be forfeited.
- 7. All bookings are subject to availability. Sponsorship material must be sent at least four (4) weeks prior to the commencement date of any such sponsored programme.
- 8. DB Corp. Ltd. (Radio Division) reserves the right to air the spots subject to availability of inventory at the time of release or during the activity period.
- 9. Positioning of the spots will always be at the sole discretion of DB Corp. Ltd. (Radio Division).
- 10. If any programme that is being offered gets discontinued, the spots will automatically be moved to the programme replacing the discontinued programme in the same rate category and the Advertiser/Advertising agency will agree to such changes.
- 11. Commercials with a time duration of less than ten (10) seconds will not be accepted.
- 12. To ensure proper release of spots, release order should be given to DB Corp. Ltd. (Radio Division) at least seven (7) days prior to the date the spots are to be first aired. Changes, if any, to be informed in advance through written communication.
- 13. The Advertiser/Advertising agency declares, affirms and assures that the contents of the advertisement/commercials to be aired are in conformity with all the applicable laws prevailing in India and have been duly censored by the appropriate government and regulatory authority and/or body. The Advertiser/Advertising agency solely responsible for the content of such advertisement/commercials to be aired by DB Corp. Ltd. (Radio Division).
- 14. The Advertiser/Advertising agency shall indemnify, save and hold harmless DB Corp. Ltd. (Radio Division) from all damages, 3rd party liabilities, costs, claims, losses, expenses, legal action and attorneys' fee arising out of the broadcast of contents of the advertisement/commercials provided by such Advertiser/Advertising agency.
- 15. DB Corp. Ltd. (Radio Division) can internally allocate the total cost (i.e. breakup between sponsorship, spot buy and others) whilst keeping the total cost and time of the negotiated package intact.
- 16. The unclaimed gifts/vouchers/rewards shall become the property of DB Corp. Ltd. (Radio Division) and DB Corp. Ltd. (Radio Division) shall have the sole right for the disbursement of the same. The validity of the gifts/vouchers/rewards shall be minimum of 90 days from the start of the activity on air.
